3. After successful submission of an application form in online mode, the filled application form must be printed and signed on each page by the applicant.



Guidelines for Applicants-

1. The required qualification and relevant experience etc. for eligibility shall be determined on the last date of receipt of application.
2. No TA/DA will be admissible for attending the interview/test in the Institute.
3. For the post on deputation, the applicant should be employed in regular service in any Government IHM/Institution.
4. For post on deputation, the application should be forwarded through the Employer OR a No Objection Certificate shall be produced at the time of Interview failing which such an Applicant may not be interviewed at all.
5. Rules regarding deputation will be applicable as per the Rules of Government of Chhattisgarh.
6. Timely amendments made by NCHMCT Noida Recruitment and Promotion Rules of Teaching staff will be applicable to be IHM Raipur.
7. No correspondence whatsoever will be entertained from the candidates regarding conduct/result of Interview and the reason for not being called for Interview.
8. A candidate found ineligible at any stage of selection his/ her candidature will summarily be cancelled.
9. The competent authority reserves the right to fill or not to fill vacancy or to re-advertise the post.
