### Mode of Application and Time limit

Interested candidates fulfilling eligibility criteria, may apply via **ONLINE** mode only by filling the prescribed application form given in the <u>website of Centre for Management Development (CMD)</u>, <u>Thiruvananthapuram (www.cmdkerala.net)</u>

- The online application submission link will be open on **16.08.2023** (**10:00 am**)
- The last date for submitting the online application is **15.09.2023** (**5:00 pm**)
- No application shall be entertained in KSIDC if it is submitted either online or offline.

### Selection Methodology

- The applications will be subjected to a scrutiny based on the details provided by the candidate, and a list of candidates eligible for further selection process will be prepared.
- The various stages of selection process (Test, Group Discussion, Interview as the case may be) will be decided based on the number of eligible applications received against the post.
- The appointment of candidates will be based on the combined score for the selection process subject to the fulfilment of other eligibility criteria, as per the norms of KSIDC/CMD.
