ELIGIBILITY CONDITIONS

The Candidate must be a citizen of India and must have attained the stipulated educational qualification, and age as on 01.08.2023.

(1) <u>AGE LIMIT</u>

- For Inspector of Income Tax: 18 to 30 years of age (i.e. candidates born not before 02.08.1993 and not later than 01.08.2005).
